- A. Consent Agenda
 - a. Head of School Report

B. Treasurer's Report

- a. Financial summary
 - i. John Eskew: enrollment is steady; revenue is down but on track as to what we thought it would be in this situation; Jodie Borgia, Julia Sutter, the teachers, and all of the staff have done a remarkable job

C. Fundraising update

- a. Giving Campaign
 - i. Julia Sutter: larger donations are coming in; the website campaign [Central Oregon Gives] ends on Christmas Eve, then we will transfer over to our own website to continue collecting donations; thinks that our fundraising goal is attainable by the end of June
 - ii. Pascaline Ocana: liked Jodie Borgia's idea of getting the children involved; the children in her class are now very aware of what the giving campaign is all about and were excited about the video that was put together
 - iii. Jodie Borgia: thinks the community as a whole is really appreciative and can see how the teachers are trying so hard and caring so much
 - iv. Sam Pierce: thinks that Julia Sutter has done really well getting the fundraising going and keeping people engaged along the way
- D. Head of School

- a. Jodie Borgia: has had meetings with ODE [Oregon Department of Education] and Deschutes County Health Services today
 - i. ODE has decided that private schools can stay open, which doesn't affect us
 - ii. Deschutes County has teachers to be vaccinated against Covid-19 in phase 1b, which would be late January at the very soonest, but probably later than that; the rest of the community will have access to vaccines in late spring/early summer
 - iii. We cannot increase our enrollment until we can have more children in the classrooms, which is dependent on vaccination rates; there is no vaccination being tested for children currently; it does take 28 days for immunity to kick in after being vaccinated
 - iv. Testing for Covid at schools: rapid tests could be used, but there are supply chain issues
 - v. Deschutes County is putting together information that they will want the schools to pass on to their communities
- Jodie Borgia attended a workshop for grant writing and learned that schools do not generally hire professional grant writers, but instead use their resources to teach staff to write grants themselves
