Karen Devlin: parent at DSM; her student transferred to DSM last year because she wasn't flourishing at her previous school; has had a positive experience at DSM and believes the teaching style makes her student want to work harder

Tara Breitenbucher: parent at DSM; encourages the board to consider taking the time to gather all feedback concerning the situation; feels her student is thriving in class and believes the teaching style used is allowing the students to get their work done

Alison Graham: parent at DSM and Montessori-trained teacher; thinks the administration and board are making decisions that are best for the business but not best for the children's education...i.e. that it is not a proper Montessori education; is, with Gavin Graham, unenrolling their oldest child from DSM

Gavin Graham: parent at DSM; was excited to grow with DSM at the beginning, but now feels that things have gone awry; does not feel that structure is being brought in with loving support towards the children; is, with Alison Graham, unenrolling their oldest child from DSM

CeCe Bangerter: parent and employee at DSM; has an office directly outside the classrooms; has witnessed students seeming quiet and normalized this year; feels control, grace, and courtesy are growing in the classroom

Jessie Anderson: parent at DSM; concerned about the negative impact she feels this school year is having on her student

John Eskew: parent and board member at DSM; feels parents and community at DSM really care about the children at the school
