2020.4.8.01 Sam Pierce moves to approve the consent agenda with the minutes revised as discussed. Kim Bangerter seconds. The consent agenda is approved by unanimous vote.

- B. Treasurer's Report
  - a. Financial summary
    - i. John Eskew: year to date financials are looking good; looking towards the future: what happens if we do not do the RPS fundraiser?
    - ii. Paycheck Protection Program (PPP) is a forgivable loan; to be used towards payroll, rent, and utilities for an 8-week period; criteria to indicate the COVID-19 virus has caused your business distress; recommends we apply for both companies and see what happens
      - 1. Jodie Borgia: it is advised that we keep good records about what we have to spend and what money we have lost; expecting/hoping some additional loans will come out in the form of grants for technology, etc.
    - iii. ADM (Average Daily Membership) funds will continue if we are providing food for the children (district) and are monitoring people coming and going in the building to ensure social distancing; this money coming in is frozen until May
- C. Expansion Committee Report
  - a. Kim Bangerter: next meeting set for 4/15/2020; there will be more to report on at May's board meeting
- D. New Business
  - a. DSMP forecasting
    - i. Kim Bangerter: would like to state that Jodie Borgia's communication has been superb throughout this crisis

- ii. Jodie Borgia: concerning DSMP: an email has gone out to the families and all of the children are participating in distance learning; the DSMP staff is onboard with this; some families have had their fees waivered; DSMP needs to stay open and running if we are to apply for the PPP loan
- iii. John Eskew: it is a good idea, but we have no guarantee if or when funding will actually occur
- iv. Jodie Borgia: does not want the distance learning program for DSMP to stop; believes our decision is whether or not to charge for DSMP going forward
- v. Julia Sutter: thinks that we should not charge for DSMP, but that the DSMP employees should be moved to the DSM payroll
- vi. Possibility that we should begin a fundraising campaign for the DSMP employees
