BUSINESS

A. Board Membership

2018.04.24.01

Shawna moves that Elvin Smith be removed from the board. Jolisa seconds. Elvin cites point of order regarding prior notice of board membership as agenda item. Given that agenda was posted on website, vote proceeds. Motion passes with Shauna, Jolisa and Shawna in favor and Elvin opposed.

2018.04.24.02

Jolisa moves that Sam Pierce be reappointed to the board. Shawna seconds. The motion passes unanimously.

- a. Shauna reminded the board that communication with school staff should go directly from the President to the Head of School, with the exception of the Treasurer's ongoing work with the Business Manager.
- B. Business Manager Report
 - a. The board reviewed the current budget in anticipation of approving it at May meeting. The current anticipated surplus should support costs of the new facility that will accrue to this fiscal year.
 - b. Regarding Scenic Drive location, recently heard from septic expert. He is recommending site is good "as is" for the upcoming 2 years given the number of kids we're currently anticipating. Going for conditional use to license as a charter school for occupancy. Architects are drawing up site plan and leading us through building and occupancy permitting. Traffic engineer talked with ODOT and the county. They both wanted a few more counts. Allowing him to use survey done for Fred Meyer and the school. Plan is to submit CUP and site plan review to county on Friday, 4/27. County's timeline is 10 12 weeks to respond with requirements. New owners got an extension on contract until July 25, after we get out of CUP permitting.

2018.04.24.03 Shawna moves to approve expenditures up to \$10,000 from 2017/18 fiscal year budget to prepare new facility. Sam abstains. Motion passes with none opposing.
